Tyonek Grown: For the past five years, TTCD has worked with the Native Village of Tyonek and other partners to develop an agricultural program aimed at enhancing food security and providing fresh organic vegetables to Tyonek. In 2016, this program was funded in partnership with the USDA National Institute of Food and Agriculture, the First Nations Development Institute, the Tyonek Native Corporation, and Rasmuson Foundation. Through this program, TTCD provided assistance to the Native Village of Tyonek through the development and management of Tyonek Garden, and provided outreach to other AK Tribal Conservation Districts and Alaska Native communities interested in starting gardening projects. In 2016, TTCD managed the Tyonek Garden to produce over 2000 lbs of fresh vegetables, a portion of which was contributed to the Tyonek See Form 990, Page 2, Part III, Line 4a (continued)

Fish Passage and Habitat: TTCD works cooperatively with many partners to strategically work towards addressing issues impacting salmon and other fish species on the west side of Cook Inlet. In 2016, this program was funded in partnership with the US Fish and Wildlife Service, the USDA Natural Resources Conservation Service, and Tyonek Native Corporation. In 2016, TTCD surveyed 90 miles of roads and 30 miles of streams for invasive plants in Tyonek, Beluga, Shirleyville, and Alexander Creek; implemented control efforts on 10 acres of invasive plants in Beluga; held two pike derbies with community members and removed a total of 181 invasive pike; continued monitoring efforts for stream temperature and juvenile salmon populations in Tyonek and Beluga; and worked with multiple partners to prioritize fish passage and culvert replacement projects for the next five years.

Technical Assistance: Through the technical assistance program, TTCD works with landowners and stakeholders in the District to achieve their conservation goals. In 2016, TTCD worked with Tyonek Native Corporation to implement a fuel break on Tyonek Native Corporation land surrounding the Native Village of Tyonek to improve protection for the community in the event of future forest fires. Also in 2016, TTCD worked with Alaska Tribal Conservation Alliance to assist AK tribal conservation districts with planning efforts, and worked with multiple partners to address energy and solid waste issues through the installation of insulation film and removal of 500 lbs of electronic waste.
